Looking ahead to this summer, we will be posting the lifeguard application the first week of February on our club website at <https://www.carefreeclub.org/Pool>. Applicant must have a current life guarding/first aid/CPR/AED certification from the American Red Cross prior to beginning work at the pool. Certification and re-certification courses are available through the JCC (<https://jccindy.org/youth/programs/youth-aquatics/american-red-cross-training/>) and the YMCA (<https://indymca.org/programs-and-activities/programs/lifeguard-training/>). Please pass this information on to those who might be interested. While Carefree members are preferred, we also need to hire from outside the neighborhood to have enough lifeguards.

Keeping the pool open regular hours once school begins is difficult since our guards either leave for college or attend high school, and many have after-school activities. If three to four adult members are interested in getting certified to work 11 a.m. to 4 p.m. during August, we would be able to maintain regular hours. Board Vacancies

The Board of Directors is looking for interested members for two positions:

- **Activities Chairperson:** This person will have the overall responsibility to plan and budget funds for activities during 2018. Four to five committee members are currently involved with planning and running the activities, and other volunteers can be brought in as needed. Popular activities include the Easter Egg Hunt, 4th of July parade and cookout, and the annual summer party with band. The first bonfire in October was also well attended, and new activities are encouraged.
- **Recording Secretary:** This position is responsible for taking the minutes for the monthly meetings of the Board of Directors. There are typically eleven meetings each year, and the recording secretary should plan on taking minutes for eight of those meetings. Other board members will take over the responsibility for the remaining meetings.
