We are still talking almost daily as payments are trickling in, so that we are all on the same page as to which properties have not paid. Current Liens: We have about 13 properties that still have a lien filed for last year's dues, who also have not paid this year's dues. I am waiting to hear back from the attorney to find out what we need to do to add this year's dues to those liens or if we have to file a new lien with the new amount. Delinquent payments: I have a letter ready to mail out to 23 members who owe ANY amount, whether just a late fee or the full dues and late fee, prepared. I am waiting on the attorney to approve, then I will mail out. It gives members until June 30th, until we begin the process to file a lien. (This does NOT include the 13 previous properties with liens that have not paid this year either) New Liens: We will begin working on filing liens in early July for those members. New Members: We currently have 3 properties in the process of joining the Carefree Club.
